

Insurance Brokerage Services

The National Agricultural Marketing and Development Corporation (NAMDEVCO) invites suitably qualified and experienced Insurance Brokers to submit proposals for the provision of Insurance Brokerage Services.

Proposals must include the following documents:-

- 1. A written proposal outlining the methodology to be adopted in managing the Corporation's portfolio;
- 2. Certificate of Incorporation or Continuance (in the case of a company) or Registration Certificate (in the case of partnership or individual). In the case of joint ventures, the certificates of Incorporation/Continuance of each company comprising the joint venture.
- 3. VAT Clearance Certificate.
- 4. Income Tax Clearance Certificates.
- 5. NIS Compliance Certificate. In the case of a company, a copy of the Annual Return filed for the year 2011.
- 6. In the case of a joint venture, a document duly signed by all the parties confirming the joint venture relationship and giving details of the arrangement and the roles and responsibilities of each organisation in the relationship.
- 7. Copy of first certificate of registration as broker.
- 8. Copy of current certificate of registration as broker
- 9. CVs of key permanent personnel (including all negotiators and brokers) signed and dated.
- 10. An organisational chart of the Applicant.
- 11. Copies of the Applicant's independently audited financial statements for the years 2008, 2009 and 2010 showing income, expenditure, profit and loss and balance sheets inclusive of notes to the financial statements.
- 12. Three (3) References from commercial/corporate clients duly signed and stamped by an authorized official of reference.
- 13. Bank Reference Letter.
